The additional areas include:

1. **CRT** - NEW fields for CRT variances
2. **TICKET** - NEW fields for Ticket Clearance, Ticket Variances, Ticket Payouts and Unclaimed Tickets

The updated reports include:

1. **Management Report**
2. **Gaming Float Reconciliation**
3. **Meter Vs Actuals Report**



With the introduction of TITO into your venue, the **Vault** application has been modified to include additional areas of reporting to ensure correct data is recorded and provided for auditing purposes.

The two new TITO functions that are now available in your reconciliation reports include:

1. **CRT** – new fields are now available for CRT variances - and
2. **TICKETS** – new fields are now available for ticket clearance, ticket variance, ticket payouts and unclaimed tickets

The reports that have been updated to include the CRT and ticket information includes:

1. The **Management Report**

The **Ticket Clearance Variance** will report any variance made between the Actual and Metered Ticket Clearance using data from the **Game** application. If your clearances are set to Auto Populate this field will be zero unless an adjustment has been made via the **Fast Payout Entry** in the **Game** application.

The **CRT Variances** provides any (A – B) variances on the **Pay Float Reconciliation** when the cashier shift was closed.

The **Unclaimed Tickets – Ticket Out** will compare TITO tickets that have been printed at the gaming machine to actual TITO tickets that have been redeemed. Values in this field could be either a ticket printed from the EGM today but not yet collected – or a ticket printed on a previous day that has been collected today.

Remember that a TITO ticket is flagged in the system as redeemed once it has been accepted in the CRT, EGM or at the cashier.
